Without exception, I accept full financial responsibility for any damage(s) to persons or properties as a result of my dog's actions at any 51 FSS/ALL PAWS OSAN PET CARE event.

I also understand that 51FSS/ALL PAWS OSAN PET CARE, its employees, owners, members, managers, officers, volunteers, representatives and any other individuals or professional entities involved with the production of 51FSS/ALL PAWS OSAN PET CARE events or services, reserves the right to refuse admittance to any unruly, aggressive, unsuitable or blatantly ill dogs. In addition, I also know that I may be asked to leave an event with my dog if I cannot properly control my dog and/or if my dog displays behaviors that are deemed to be disruptive or dangerous.

In short, I affirm that I am the ONLY one responsible for my dog and I agree to indemnify and hold harmless any other person, company or organization from any liability resulting from my dog's attendance at an event.
